Special Meeting to Interview Candidates for Officer

Mayor Lake called the meeting to order @ 6:00p.m.

Roll call vote was taken Alderman May here, Alderman Gish here, Alderman Meyer here, Alderman Cole here, Mayor Lake here

Alderman Gish Made the motion to approve the agenda. Second by Alderman Cole all in favor motion passed.

Alderman Gish made a motion to move to open session, Alderman Meyer second all in favor motion passed.






Alderman Meyer made the motion to Adjourn Alderman Gish second all in favor meeting adjourned at 7:00 pm.
