council addressed the issue of no officer in town. The Mayor has been advertising for help and will continue to do so along with trying to find a retiree.

Charlotte Morrison informed the board that she has spoken to the Sheriff about the dates for the Street Fair. The board discussed the closing of Boonville street, Vine street and Grover street during the street fair. Alderman Mark Cole made a motion to approve the street closure, Alderman David Young second, motion passed. Also discussion was held on the Fair board members using ATV's and golf carts during the fair. Alderman Sean Main made a motion for such use as long as they are tagged, Alderman Mark Cole second, motion passed.

Old Business: East Side Streets: The City has, as of today, received a bid from Murphy's Sealcoating LLC for street repair. The board would like to have the Mayor check into other work Murphy has done and also seek other bids. Mayor Lake will report back to the board.

Water Tower Valves: MMLC Marty Masters spoke to the board concerning his advice about how the city needs to proceed with finding where water lines run and what valves shut off those lines. Valves need to be operational and exercise them periodically. When MMLC checked out the valves around the water tower and others close to City Hall they found some valves were turned off. Mr. Masters did not want to waste the City's money so that is why he suggested the city find lines and valves and then the information can be entered into the Diamond Map program that shows where meters are located. When we need help with hydro vac needs MMLC will return to work with the City.

New Business: Tax Rate Ordinance: This issue was already discussed and passed in the Tax Levy Meeting earlier.

Mayor Lake requested a motion to move this meeting to closed session to discuss legal issues and employee related issues.
