Mayor Lake requested a motion to add to the agenda purchase of water rings for meters. Alderman David Young made the motion to approve the agenda, Alderman Sean Main seconded, all present in favor, motion passed.

Mayor Lake requested a motion to approve monthly bills. Alderman John Meyer made the motion to approve the monthly bills, Alderman Mark Cole second all present in favor, motion passed.

Mayor's Comments: Mayor Lake reported to the board that the CD's with Tipton Latham Bank due July 9, 2024 the transaction will be completed by Mayor Pro Tem John Meyer. They will be changed over to The Bank of Otterville.

Charlotte Morrison informed the board that the Street Fair will need a letter from the City giving permission to the Street Fair for Liquor Sales during the weekend of September 13th and 14th. Alderman David Young made a motion to approve issuing the needed letter, Alderman Mark Cole second motion passed. Charlotte also requested that some streets will need to be closed

during the street fair also. Since the board did not have a list of the street names this was tabled until the next meeting.

Old Business: East Side Streets: Alderman John Meyer reported that Lance Murphy has not yet looked at the streets but as soon as he does he will give the City a bid for that work.

Water Tower Valves: MMLC meet with Mayor Lake and Alderman John Meyer concerning the valves under the water tower that do not work. There is an estimate of \$14,823 in the board packets for MMLC to perform this work. They will check all the valves in the water tower yard to see if they are active and the water tower will need to be drained for their pot hole work to be done. Alderman Sean Main made a motion to accept the MMLC bid Alderman John Meyer second motion passed.

New Business:

Side by Side: After a discussion was held about the City purchasing a side by side to be used for various jobs around town a motion was made by Alderman Sean main to table this item until the water tower valves work has been completed. Alderman John Meyer second, motion passed.

The purchase of rings for water meter lids Alderman Sean Main made a motion to have the maintenance man figure out how many need to be purchased so table this purchase until the need meeting. Alderman Mark Cole second motion passed.
